4. Article II of the Articles of Incorporation is hereby amended to read as follows:

The purpose or purposes for which the corporation is organized are: 1) To promote river restoration so that the Rouge River supports clean water uses, including fishing, boating, and swimming. 2) To promote Rouge River corridor development that would provide recreational opportunities such as canoeing, nature study, picnicking, fishing, swimming, walking, biking, and golfing. 3) To provide for citizen participation in river restoration and preservation activities. 4) To educate citizens about problems and opportunities of the Rouge River and its watershed. 5) To advocate actions that restore and develop the potential of the Rouge River. 6) To foster cooperation among all citizens, agencies, private interests, and governments concerned with the restoration and preservation of the Rouge River.

Said organization is organized exclusively for charitable, religious, educational, or scientific purposes under section 501(c)(3) of the Internal Revenue Code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributed to members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth hereof.

No substantial part of the activities of the association shall be the carrying on of propoganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in any political campaign on behalf of any candidate for public office.

ARTICLE II (continued)

Notwithstanding any other provision of these articles, the organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Code, or by an organization contributions to which are deductible under section 170(c)(2) of the Code.

Upon dissolution of the organization, the officers shall, after paying or making provision for the payment of all the liabilities of the association, dispose of the remaining assets of the organization to such organizations organized and operated exclusively for charitable, education, religious, or scientific purposes which at the time qualify as exempt organizations under section 501(c)(3) of the Code.
